



## Assumption of Risk

I further understand and acknowledge that the responsibility for this event participation is borne by me as a parent.

1. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular skills, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my child's participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation for my child. If, however, I observe any unusual significant hazard during my presence or participation, I will remove my child from participation and bring such to the attention of the responsible party immediately; and,
4. I, for myself, my child and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS CTV, Inc. (a.k.a. Club Texas Volleyball), its owners, directors, coaches, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used for the activity ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property associated with my presence or participation, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

This is to certify that I, as parent/guardian with legal responsibility for this participant, do consent and agree to his/her release as provided above of all the Releasees, and, for myself, my child and our heirs, assigns, and next of kin, I release and agree to indemnify and hold harmless the Releasees from any and all liabilities incident to my minor child's involvement or participation in these programs as provided above, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES, to the fullest extent permitted by law.

## Athlete Code of Conduct

**In order to ensure the safety and well-being of the athletes, coaches, and parents of Club Texas Volleyball, and to best represent the program, players and coaching staff, I hereby agree to abide by the following Code of Conduct:**

**I understand the following with regards to playing time/positions:** Playing time and positions are not guaranteed. Coaches will determine playing time and positions as they deem necessary and appropriate for the benefit of the team. There is, however, no guarantee made as to any player's playing time.

- \* I will show sportsmanship and respect toward all opponents, teammates, spectators, officials, coaches and parents.
- \* I will refrain from any physical action that may endanger the safety and well-being of any person I come into contact with while participating in the Club Texas Volleyball program.
- \* I will refrain from any verbal or written action that may detract from the integrity of the program or an individual. I will verbally support all members and their parents of the Club Texas Volleyball Program, as well as the players and parents from other programs. This includes any communications shared via social media.
- \* I agree to uphold all laws and regulations as dictated by local, State and Federal governments (i.e. underage drinking, smoking, assault, shoplifting, etc.) while under the supervision of the Club Texas Volleyball program.
- \* I agree to abide by any nutritional guidelines as established by the Club Texas Volleyball coaches for athletes.
- \* I will adhere to any training requirements as established by the Club Texas Volleyball coaching staff. I understand that these training requirements are in addition to any other requirements set forth by other sport activities and training in which I may be involved.
- \* I agree to respect the property of others (teammates, hotels, gyms, etc.) and to pay for any losses and/or damages that I am found responsible for.
- \* I agree never to leave the gym or hotel without permission from the coaching staff. Should I be granted the permission to leave, at those times, I will be accompanied by members of the Club Texas Volleyball program or my parents.
- \* I agree to abide by curfew rules set for the athletes for any overnight trips.
- \* I understand that on any trip or at any tournament, I am under the direct responsibility and authority of the Club Texas Volleyball coaching staff and my parents and I will follow and abide by all reasonable rules and decisions made by these persons.
- \* I agree not to be in the possession of or utilize illegal drugs, tobacco and/or alcohol. I also agree not to be in the possession of vaporizing devices such as e-cigarettes or "vape pens". I also agree not to be found in the presence of such substances being used by other youths or I will be found equally at fault.
- \* I understand that violation of the code will result in disciplinary action that may include expulsion from the Club Texas Volleyball program. There will be no financial reimbursement for any violation of the policy that results in dismissal from the program.

## Parent Code of Conduct

- \* Remain in the spectator areas during all games.
- \* Not advise the coach on how to coach, who to put in the game, and/or who to take out of the game.
- \* Not discuss my complaints with the coach at any tournament. I understand that I will be given adequate opportunity to discuss any issues or complaints with my daughter's coach during an arranged time away from a tournament setting with an additional club representative in attendance.
- \* Respect the integrity of the officials and not advise them how to call the match.
- \* Model sportsmanship for my child by treating all coaches, officials, tournament directors, and players of either team with courtesy and respect.
- \* Encourage hard work and honest effort that will lead to improved performance and participation.
- \* Emphasize the cooperative nature of the sport.
- \* Not coach my child during the game.
- \* Encourage athletes to participate in volleyball drug, tobacco, and alcohol free.
- \* Cheer for my child's team.
- \* Encourage my child to participate for enjoyment as well as competition.
- \* Applaud good and fair play during matches.
- \* Be in control of my emotions.
- \* Learn the rules of the game to help me better understand what is happening on the court.
- \* Understand that physical or verbal intimidation of any individual is unacceptable behavior.
- \* Be supportive of all attempts to remove verbal or physical abuse from organized volleyball activities, including language.
- \* Understand that conduct that is inappropriate as determined by comparison to normally accepted behavior is unacceptable.
- \* Protect the ability to continue using the facility by following all the rules of the facility.
- \* Protect athletes from sanctions and/or suspension by producing accurate documentation.
- \* Honor financial all commitments regardless of injury, match playing time or other.
